The Colorado Association for Viticulture and Enology (CAVE) invites you to submit original artwork for the 27th Annual Colorado Mountain Winefest in Palisade (September 13-16, 2018). The winning artwork will represent the Colorado Winefest in poster, and potentially advertising and promotional pieces. The 2018 contest is open to both fine art and graphic design artists.

Artists must be residents of Colorado.

We are seeking artwork that represents the growing wine industry in the state of Colorado and is not region specific, but state specific. The Winefest Art Committee will select the finalists, and the winning artwork will be chosen by the public during our Art Reception. **The winning artwork will be purchased for \$700** (to include all exclusive reproduction rights and copyrights). All eligible entries will be displayed at The Blue Pig Gallery in Palisade and all entries must be for sale (excluding the winning entry) at your asking price less The Blue Pig Gallery Visiting Artist Commission of 40%. The artwork will be displayed from January 26, 2018 through February 2, 2018.

2018 COLORADO WINEFEST ART CONTEST CONTEST RULES AND SPECIFICATIONS

NOTE: PLEASE READ AND SIGN YOUR ACCEPTANCE ON THE ART CONTEST ENTRY FORM

I HEREBY AGREE TO AND ACCEPT ALL THE FOLLOWING PROVISIONS:

1. Art contest is open to any COLORADO resident and is open to two dimensional original art and original graphic design art. The artist's signature must appear on each entry. Photography and three dimensional art are not eligible. Each artist may submit more than one piece at a fee of \$20.00 per piece. Previously submitted artwork in this contest is acceptable. Artwork should reflect the Colorado wine industry.
2. Artist is responsible for all coordination and cost of shipping of artwork in a reusable shipping container submitted to CAVE. Artist is responsible for removing artwork from The Blue Pig Gallery or payment of return shipping. All entries must be received at the CAVE office (124 West 3rd Street, Palisade, CO 81526) **no later than January 5, 2018** during regular business hours along with signed entry form(s), fee(s) and signed Blue Pig Guest Artist Contract. All art must arrive adequately packaged and labeled with 1) ARTIST NAME; 2) TITLE; 3) MEDIUM and 4) PRICE marked clearly on back of artwork*. Graphic design art submissions must arrive printed, mounted, and framed as original artwork along with VECTOR files with all fonts converted to outlines on CD or DVD. *(labels provided)
3. Artwork must be no larger than 24 inches x 36 inches, vertical or horizontal, signed, framed and **ready to hang with secured, closed eye-hooks and wiring**. All entries must arrive with a protective covering of clear acetate or plastic. Pastels may or may not be treated with fixative. Graphic artwork CDs or DVDs should arrive in a jewel case or padded envelope. Artwork not ready for display as indicated, or excessively fragile artwork requiring more than normal hanging and consideration, will not be accepted. The Blue Pig Gallery reserves the right to install hardware in any manner deemed necessary for exhibition or security reasons.
4. Artist guarantees that the work has not been published prior in any medium.
5. CAVE will purchase the winning artwork piece (or graphic files if applicable) for the amount of \$700, and receives possession of the original artwork and all exclusive reproduction rights worldwide forever. In the circumstance that the artwork is digitally created, CAVE receives complete files, at 300 dpi resolution or more, for printing at 100% size for the commemorative poster at approximately 18" x 24". **The original art piece will be owned by CAVE.**
6. CAVE has the winning artist's irrevocable permission, without restriction, to use images of the winning artwork for the reproduction of posters, brochures, advertising, media outreach, educational and promotional materials for our events in addition to other events as CAVE may determine in their sole and absolute discretion.
7. Artist agrees to sign 200 posters for Winefest use and agrees to attend Colorado Mountain Winefest. Winefest will provide two general admission tickets to the event. All travel and incidental costs will be at the artist's expense.
8. Artist is solely responsible for insuring his/her artwork. CAVE and The Blue Pig Gallery will not insure the artwork in any manner and the artist waives any claim of any nature against CAVE and The Blue Pig Gallery for any loss, theft, or physical damage (including fire, vandalism and flood) that may occur to such artwork while it is in transit or in the care, custody and control of CAVE, The Blue Pig Gallery, its successors, assignees or agents.
9. The winning piece of art will be selected from the finalists by the Public the evening of January 26, 2018 at the Artists' Opening Reception and the winning artist will be announced at that time. All artwork submitted will be displayed at The Blue Pig Gallery, 103 West 3rd, Palisade, CO. All artists are encouraged to attend. All submitted artwork will be available for viewing and all non-winning art will be available for purchase at The Blue Pig Gallery from January 26, 2018 through February 4, 2018. All artwork will be subject to The Blue Pig Gallery Artist Contract (including a 40% Guest Artist Commission fee from any art sales). The enclosed Blue Pig Gallery Guest Artist Contract must be signed and submitted with your entry.
10. All artwork not sold must be picked up between February 3-4, 2018. Any artwork left in the Gallery after these dates will be charged a \$20.00 per day storage fee (until artwork is picked up or return shipping payment arrangements are finalized).

GUEST ARTIST CONTRACT
(For Colorado Winefest Art Exhibition)

This agreement made by and between The Blue Pig Gallery (Gallery) and _____
(Artist) this ____ day of _____, 20 __, is for display of artwork piece listed below, for a period to
begin January 26, 2018 and not to exceed February 4, 2018.

1. Artist must submit entry ready to hang with secured, closed eye-hooks and wiring.
2. Gallery receives a 40% commission from the original price of the art exhibited at the Gallery during the terms of the agreement. All discounts given on sales are at the discretion of the gallery.
3. Gallery maintains control over the installation of art work. Gallery reserves the right to use images of the art work on display for the purpose of sales and marketing.
4. Gallery reserves the right to levy a charge for art work commissioned for artist during the term of the exhibition. Such charges will be handled on case by case basis.
5. Gallery reserves the right to use artist's name and image for promotional purposes.
6. Artist agrees to provide artist's statement, autobiography and any useful promotional materials to the Gallery for marketing purposes. Gallery director may edit when needed.
7. Artist agrees to provide names of any galleries where art work by artist may be seen.
8. Artist has signed and submitted entry form for the Colorado Winefest Art Contest and understands all terms in both agreements.
9. All art work must be picked up from the Gallery during regular business hours on Saturday, February 3rd or Sunday, February 4th from 10:00 a.m. to 5:00 p.m.
